9. A hearing on all Motion(s) to Dismiss (filed on or before June 18, 2009) shall be held on July 1, 2009 at 9:30 a.m. The hearing shall take place in Room 330 in Courthouse East unless otherwise notified by the Court.
10. Any Answering Memoranda in response to the Petitioners' Memorandum of Law, pursuant to Maryland Rule 7-207 shall be filed on or before July 6, 2009 at 12:00 p.m.
11. Any and all Reply Memoranda in further support of the Petition(s) for Judicial Review, pursuant to Maryland Rule 7-207 shall be filed on or before July 8, 2009 at 12:00 p.m.
12. A hearing on the Petition(s) for Judicial Review shall be held on July 9, 2009 at 9:30 a.m. The hearing shall take place in Room 330 in Courthouse East unless otherwise notified by the Court.
