SCHEDULING ORDER

As a result of the Scheduling Conference held in chambers on March 10 2009, it is this 10th March 2009, by the Circuit Court for Baltimore City, Maryland

ORDERED that Marian Soto, Criminal Clerk Manager in the Criminal Clerk’s Office (Room 252 of the Mitchell Courthouse) shall be the custodian records for these cases when these matters are not in proceedings, and all parties in these matters shall file all papers with Marian Soto, the parties shall file all papers in these proceedings with Kimberly Foxworth, Criminal Clerk Supervisor, should Marian Soto not be available; and it is further

ORDERED that a hearing on any preliminary motions, including but not limited to exceptions to discovery and demand for bills of particular, shall be held on Thursday, March 26, 2009, at 10:00 a.m. in Courtroom 230, Courthouse East; and it is further

ORDERED that the State's response to any Defendant's exceptions shall be filed with Marian Soto no later than Wednesday, March 18, 2009; and it is further;

ORDERED that any Defendants' reply to the State's response shall be filed with Marian Soto no later than Tuesday, March 24, 2009; and it is further

ORDERED that a hearing on any motions to dismiss or similar motions shall be held on Thursday, April 23, 2009, at 10:00 a.m. in Courtroom 230, Courthouse East; and it is further

ORDERED that any motions to be heard on April 23, 2009, shall be filed with Marian Soto no later than Tuesday, March 31, 2009; and it is further

ORDERED that the State's response to any Defendant's motions to be heard on April 23, 2009, shall be filed with Marian Soto no later than Tuesday, April 14, 2009; and it is further

ORDERED that any Defendant's reply to the State's response shall be filed with Marian Soto no later than Monday, April 20, 2009; and it is further

ORDERED that the State shall file their responses to Defendant Holton's Motion to Dismiss and Defendant Lipscomb's Motion to Dismiss no later than Wednesday, March 18, 2009; and it is further

ORDERED that the Court will hear argument on the issue of consolidating the case involving Defendant Holton and the case involving Defendant Lipscomb at the hearing scheduled for March 26, 2009, assuming that one or more parties have filed a motion to consolidate no later than Monday, March 23, 2009; and it is further

ORDERED that, pending any further Order, these cases are not consolidated for trial at

this time; and it is further

ORDERED that the trial involving Defendant Lipscomb shall begin on Monday, June 22, 2009; and it is further

ORDERED that the trial involving Defendant Dixon shall begin on Tuesday, September 8, 2009; and it is further

ORDERED that the trial involving Defendant Holton shall begin on Monday, October 5, 2009.
